# STEP 1: Call Younth R to fill your YCANTH Prescription



After your appointment, please call **YcanthRx at (855) 403-2364** to fill your prescription as ordered by your provider.

#### During the call, YcanthRx will:

- Verify your insurance coverage and confirm your next appointment.
- Help you save on the cost of your medication with the YCANTH Copay Program. With the Program, commercially insured patients can pay just \$25 per YCANTH treatment visit.\* Eligibility requirements apply.



YCANTH will be shipped directly to your doctor's office for your next treatment.

## STEP 2: **Follow-up Appointments**

Please note: Most patients require more than one treatment to completely clear their bumps. You or your child remain contagious until all bumps are clear.

## What To Do After Treatment



Wash all treatment sites 24 hours after treatment with a gentle soap and water. Avoid washcloths or abrasive surfaces. You may wash YCANTH off of your skin sooner if directed by your healthcare provider, or if severe application site reactions occur.



Avoid creams, lotions, oils, and sunscreen on the treated skin. These products should not be applied for 24 hours or until after washing the affected and treated skin.



If discomfort occurs, over-the-counter medicine such as acetaminophen or ibuprofen can be taken as needed. Local skin reactions are expected and should be reported if they are severe.

### **What to Expect Post Treatment:**

#### After treatment:

If you experience discomfort, use an over-the-counter pain medication. Blisters form within 24 to 72 hours.

#### The next few days:

Avoid squeezing, "popping," or scratching any blisters, as they could become infected.

#### Seven to 14 days after treatment:

If scabs form at the treatment sites, try to avoid picking or scratching—removing the scab can increase the risk of scarring.
